- a) Report from Fillmore County Sheriff and Emergency Management team on Emergency Management Protocol – Sheriff DeGeorge and Deputy Harmening:
 - i) Fillmore County Emergency Management uses multiple sources for information during inclement and/or threatening weather to determine the best course of action, as well as who to notify depending on where the weather will be. There is limited cell phone reception as well as limited radio capabilities in portions of the county, so in places where that form of communication is limited, the County Sheriffs Department, with assistance from local city Police Departments, Volunteer Fire Departments, city Fire Departments, weather spotters, etc., will go out and notify impacted people and businesses in person. Municipalities will also be notified.
 - ii) Local internet providers have really been working to increase access to broadband internet in rural parts of the county; this is especially helpful in places where cell phone reception is limited. Many newer cell phones have Wi-Fi calling and texting capabilities, so if close enough to Wi-Fi reception, emergency alerts can still be received via cell phones.
 - iii) Fillmore County provides a service called Code Red for emergency weather alerts; visit <u>https://www.co.fillmore.mn.us/</u> for more information.
 - iv) If any person wants to alert the Sheriffs Department of threatening weather, travel impacts, flood impacts, or other situations in which property or human safety is at risk, CALL 911.
